## **Foreword**

Six years have passed since the Centre for Democracy Aarau moved into the Villa Blumenhalde. The villa is a place where we now come and go on a daily basis. We have conducted dozens of events and seminars in the Blumenhalde. We have received guests from all over the world who have shown an interest in Swiss Democracy. Among these have been delegations from Mongolia, from our neighbouring states including Germany, Austria and France, from Bulgaria, Uruguay and Argentina. A television team from the Ukraine even came to film a documentary about Switzerland, conducting interviews with some of us in the garden in the springtime. And we have of course worked here on our research projects: analysed and interpreted data, discussed results, gained new insights, and recorded and prepared these for publication. Within these walls we have experienced countless light-bulb moments or better ‘Eureka!’ experiences, such as when after extensive thinking about a question or intensive calculations of a dataset the realization sets in that one has just discovered something new. These are moments that give great satisfaction and which motivate us as researchers.

One can think of no better place than the Villa Blumenhalde for this. It offers spaces for stimulating discussions. It offers spaces for events. It offers spaces to pause and reflect. And it offers the necessary quiet to work productively; so productively in fact that during the last years we have seen a significant increase in the number of externally financed research projects. With this the number of employees has grown, as has the demand for space. Already in 1848 Heinrich Zschokke, who built the villa, wrote in a letter to a friend after a gathering of his large family: ‘The house was almost too small!’ It was becoming too small for us as well. We had to resort to double or triple occupancy of working spaces and setting up extra workspaces in the rather dark foyers. Thanks to the well-designed extension of the Villa Blumenhalde, constructed in the second half of 2014, these space issues have now been solved. With this we now have twelve additional workspaces, as well as new windows and a much improved acoustics in the seminar room. We are very grateful to the owner of the building, the Ortsbürgergemeinde Aarau (the citizens of the municipality of Aarau) for having made this extension possible. Work in the Villa Blumenhalde will be even more enjoyable now!

The inauguration of the extension in conjunction with an open day of the ZDA was without a doubt a highlight of 2014. More than 140 guests from the whole region took part in the celebration, listened to speeches – the guest speaker was former federal councillor Moritz Leuenberger – and to the presentations of research projects by the employees of the ZDA. The interest shown was considerable and once again showed how well-established the ZDA is within the local community. Both of the traditional annual ZDA events also met with a lively interest from the public. In March, the Aarau Democracy Days took place for the sixth time and were devoted to the topic ‘Democracy in the Community’. In addition to the interested locals, this time there were also a conspicuously large number of municipal authorities who came from more distant cantons – even from Zurich! The late summer event of the *Friends of the ZDA* Association at the beginning of September also met with a great deal of interest: prominent guests from politics and administration discussed the opportunities and risks of electronic voting with ZDA researcher Uwe Serdült.

Scholarly research on the subject of *Democracy* is and will continue to be the main mission of the ZDA: this year the list of completed research projects and published results is very long. Of particular note, however, was the completion of the project financed by the Commission for Technology and Innovation (KTI), *Play Swiss Lex*, in the summer. Within the framework of this project the ZDA developed a role-play game about the process of law making at a federal level. In July, this innovative teaching material was tested, initially as a smaller pilot

project at the *Neue Kantonsschule Aarau* (equivalent to a British grammar school). Then, in August it was implemented for the first time in the *Alte Kantonsschule Aarau*. A total of 250 students took on the role of parliamentarians and simulated true to detail the debates of the National Council and the Council of States on formulating the hooligan law. With the launch of the game the research work on this project has been concluded. With the support of the technology transfer centre of the University of Zurich, the ZDA established a spin-off company, which has now taken on the distribution of the new teaching material ([www.politik-macht-gesetz.ch](http://www.politik-macht-gesetz.ch)). Not only was the collaboration of both of the ZDA departments ADF and PBGD decisive, but also the support of the cantonal schools of Aarau. The project is, thus, a successful example for how the ZDA, with its combination of expert knowledge in different disciplines and connections to the local community, can use opportunities for scientifically innovative research and development work.

## **I. ZDA-internal**

### **1. Organisation**

#### *a. Partners*

With regard to the partnerships of the ZDA with the city of Aarau, Canton Aargau, University of Zurich (UZH) and the University of Applied Sciences and Arts North-western Switzerland, there have been no changes during the reporting year.

#### *b. Board of Partners*

The Board of Partners is composed of two delegates each per partner:

- Regierungsrat Alex Hürzeler (Chairman, BKS, Representative Canton Aargau)
- Dr. Katja Gentinetta (Representative Canton of Aargau)
- Jolanda Urech (Mayor of Aarau, Representative City of Aarau)

- Prof. Dr. Otfried Jarren (Prorector Humanities and Social Sciences, Representative UZH)
- Prof. Dr. Thomas Gächter (Institute of Law, Representative UZH)

- Prof. Dr. Hermann Forneck (Director College of Education, Representative FHNW)

On 1 January 2014, three new members of the board of partners took up their positions. Jolanda Urech replaces Mayor Marcel Guignard who resigned at the end of 2013. Prorector Otfried Jarren now represents the UZH, replacing the former rector Andreas Fischer. Katja Gentinetta will be representing Canton Aargau, replacing Thomas Pfisterer.

At the meeting on 17 March 2014 the Annual Report and Annual Accounts of 2013 were approved in the new reporting format. In connection with this the board and partners discussed the definition of the targets with regard to the third-party quota. The GM approvingly took note of the planned and implemented measures to sustainably establish the research agenda of NCCR Democracy at the ZDA. Within the framework of strategy development, the board was mandated to formulate a personnel strategy. In addition, a dialogue between the mother institutes was initiated concerning doctorate conferrals of staff in the PBGD/FHNW departments at the UZH.

The second regular meeting of 03 November 2014 was held in the Aarau City Hall due to ongoing construction work in the Blumenhalde. The partners approved the 2015 budget of the ZDA and passed formal codes of practice for new elections/succession procedures of board members of the ZDA. The personnel strategy presented by the board was discussed and approved. Councillor A. Hürzeler was unanimously elected as chairman of the partners' meeting for the 2015–16 term. The attendees unanimously elected D. Kübler for a further term (2015–16) as chairman of the ZDA board.

#### *c. Directorate*

The directorate is the operative management body of the ZDA and is composed of the heads of the three departments who are at the same time professors at the UZH and/or the FHNW. The chairmanship is held for two years by a member selected by the GM. In the reporting year, the configuration was as follows:

- Prof. Dr. Daniel Kübler, Chairman Directorate ZDA 2013–2016, Department Head ADF; Professor for Democracy Research and Public Governance at the UZH, Director of NCCR Democracy;
- Prof. Dr. Andreas Glaser, Department Head c2d, Professor for Public Law at the UZH;
- Prof. Dr. Béatrice Ziegler, Department Head PBGD, Professor at the FHNW and Head of the Centre for Citizenship and History Education.

In 2014 the directorate convened at eight formal meetings; informal discussions took place on a regular basis. The key issues with which the directorate was concerned, were realising the 2014–2017 development plan with regard to research, but also external communication (website/brochure), various public events (6<sup>th</sup> Aarau Democracy Days in March, the inauguration of the building extension in December) and the management of measures in connection with the construction of the extension (infrastructure renewal UKV and IT), as well as administrative modifications (implementation of the new personnel regulations of the UZH and the development of a personnel strategy).

*d. Scientific Advisory Board*

The configuration of the Scientific Advisory Board remains unchanged in the reporting year. The members are:

On 8 September 2014, the ZDA advisory board met for its annual meeting at the UZH in Zurich-Irchel. Present were: Prof. Giovanni Biaggini as well as the members of the ZDA directorship. Connected via videoconference were Professors Dietlind Stolle (Montreal/Berlin) and Yannis Papadopoulos (Lausanne). Those members not present in person communicated their input and comments in writing. The topics of discussion were the activities and developments of the ZDA in the reporting year (research output/publications, cross-departmental collaboration, public relations, change of management PBGD and personnel strategy). The opinions and discussions were summarised in a report for the attention of the annual general meeting. In general, the advisory board members issued the ZDA with a very good testimonial, in particular with reference to the research output productivity of the staff, but also for its presence in the research community and in the public sphere.

## 2. Staff

At the ZDA there were 58 staff members in the reporting year (as of 31.12.2014: 43) with a total of 2,522 full-time equivalents.

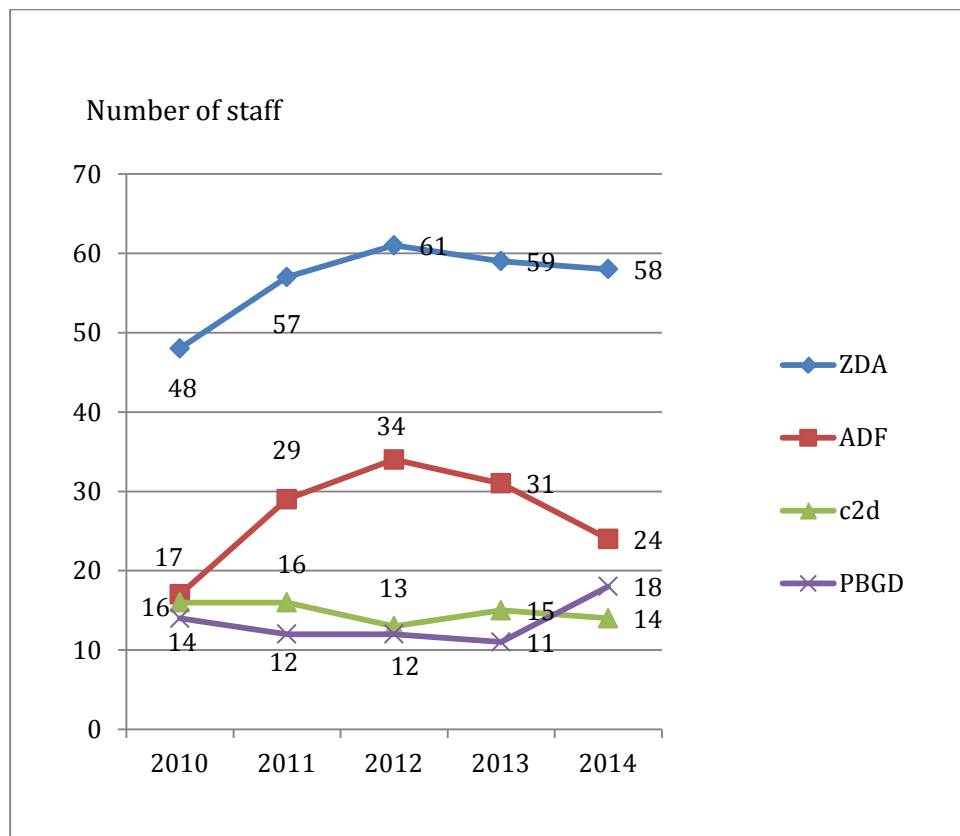

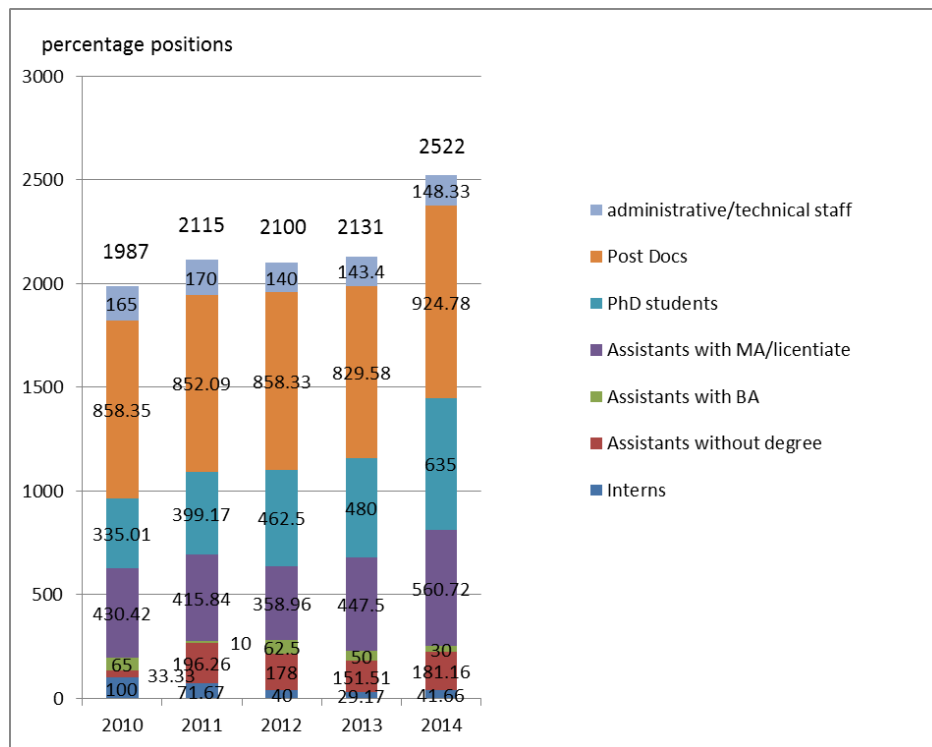

### **3. Team seminars**

In addition to regular internal departmental coordination and strategy meetings, at ZDA team seminars, research projects selected from the three departments are presented and discussed for the advancement of interdisciplinary collaboration.

The first team seminar took place on 17 January 2014. Claudia Schneider reported on "die (Nicht-)Integration von Politischer Bildung in den LP21", Céline Antonini and Nenad Stojanovic presented their findings from the research and consultancy project (supported by the DEZA) under the title "Hope is the last to die: the Swiss (and ZDA) contribution to constitutional reform in Bosnia and Herzegovina". This was followed by Yanina Welp's presentation of research results on the question "Recall – political weapon for bad losers or instrument of accountability?"

All staff then met for the annual end of year dinner.

At the second team seminar of 13 June 2014, Monika Waldis provided first insights into the research project "VisuHist – Ausprägung und Genese professioneller Kompetenz von Geschichtslehrpersonen". This was followed by a presentation by Corsin Bisaz and Nenad Stojanovic of their respective Ambizione project submissions "Bedingungen direct-demokratischer Legitimation" and "Are voters morally allowed to discriminate against minority candidates and, if so, how should we measure electoral discrimination?"

### **4. Cross-departmental Collaborations**

As mentioned in the foreword, the project *Play Swiss Lex*, financed by the Commission for Technology and Innovation (KTI), was completed in summer 2014. Within this framework, in an interdisciplinary collaboration of ADF and PBGD, a role play exercise on the federal level legislative process was developed. In July this innovative teaching tool was tested at the Neue Kantonsschule Aarau. It was then implemented at the Alte Kantonsschule Aarau in August. Altogether 250 students took on the role of parliamentarians for one day and simulated true to detail the debates of the National Council and Council of States in formulating the law on hooliganism. After the launch of the game, the scholarly works on this project have now been completed. With the support of the Technology Transfer Centre of the University of Zurich,

former members of staff of the ZDA and members of the 'Friends of the ZDA' association founded a spin-off venture, which has now taken on the distribution of the new teaching tool ([www.politik-macht-gesetz.ch](http://www.politik-macht-gesetz.ch)).

Furthermore another cross-departmental project was initiated: ADF and c2d staff members are currently working on a 'work package' within the framework of the EU FP7 project *bEUCitizen*. The topic of the project involves different questions on the dynamics and effects of the European citizens' initiative. This project will be completed in spring 2016.

## **5. Facilities**

The extension of the Villa Blumenhalde took place in the second half of the year. This was completed on schedule in November. The ZDA now has at its disposal four new offices with twelve workplaces. The extension was inaugurated with an open day celebration on 6 December.

Parallel to the work on the extension, the renewal of the IT infrastructure was undertaken. This had become necessary with the move of the Pädagogischen Hochschule (College of Education) to the Brugg/Windisch campus. This work has since been completed.

## **6. The *Friends of the ZDA***

The "Friends of the ZDA" association in existence since April 2009 promotes the development of the ZDA and strengthens its position among the citizens, in politics and business. At the end of 2014 the association had almost 300 members. Uwe Serdült is a member of the association board and functions both as a representative and link to the ZDA. 3–4 board meetings take place per year in the Blumenhalde.

The annual late summer event for the members of the association took place in the auditorium of the *Alte Kantonsschule Aarau* this year due to the ongoing construction work in the Villa Blumenhalde. Uwe Serdült spoke on the subject of "E-Voting: Funktioniert die Demokratie auch elektronisch?" This was followed by a podium discussion with Balthasar Glättli (National Councillor of the Greens Party), Dr. Peter Grünenfelder (Staatschreiber [administrative head of state chancellery] Kanton Aargau) and the speaker moderated by Dr. Katja Gentinetta. After the event, the members of the association were invited to the traditional risotto dinner.

## II. Research

### Research Focus 1: Direct Democracy

The Swiss National Science Foundation (SNF) has approved the *research project "Die Umsetzung erfolgreicher Volksinitiativen in Rechtsetzung, Rechtsanwendung und Rechtsprechung"* with a grant of CHF 387,504 for a three year period. This will provide funding for two doctoral candidate positions (60 percent each) and an assistant (20 percent).

Since 2004 no fewer than nine popular initiatives were successful at federal level. Almost all adopted initiatives resulted in legal difficulties in their implementation. In the foreground are conflicts with requirements concerning international law and principles of constitutional law as well as a lack of clarity in how the text has been formulated. The research project studies the specific legal problems and develops approaches for solutions in order to improve the realisation of initiatives.

## Research Focus 2: Democratic Institutions in Comparison

### *Entzauberte Schweizer Demokratie – die politische Schweiz im 21. Jahrhundert*

In the post-war era, the Swiss model of democracy was defined by three foundational pillars: by consociationalism, a pronounced federalism and liberal corporatism, that is, by a close collaboration of the state with organisations. Is Swiss democracy still the same in the 21<sup>st</sup> century?

The ZDA launched a scholarly ‘challenge to the myth’ of Swiss democracy in the reporting year and in January 2014, together with the University of Zurich and NCCR Democracy, organised a conference with 17 scholarly contributions. The ZDA team’s focus was above all on the development in the consociationalism of government and the increased collaboration of the cantons. The research was reflected in public appearances, a round table with extensive public participation and media coverage. In addition, we are preparing a special edition of the *Schweizerischen Zeitschrift für Politikwissenschaft*, which is due to appear in autumn 2015. The editors will be Daniel Bochsler, Silja Häusermann and Regula Hänggli.

### **Research Focus 3: Democracy and its Citizens**

Commissioned by the Department of Economic and Internal Affairs of Canton Aargau and the Association of Municipal Mayors, the ZDA carried out a study entitled *Milizorganisation der Gemeindeexekutiven*. Based on an evaluation of the records of communal elections since 1970, as well as a survey on the ZDA's own account of local governments, the problems concerning recruitment for political functions in the municipalities of Aargau were studied and recommendations for change made. It became evident that overall the recruitment problems had increased, mainly in the smaller, more rural municipalities. Today, three quarters of all municipal elections are non-controversial, that is, the number of candidates corresponds with the number of available seats. This tendency is worrying: elections without a choice are poison for democracy. In order to counteract this trend, we recommend a well-grounded discussion on the adequate remuneration for *milizämter* (official positions taken on by 'laypersons'), more flexible remuneration models and improving the perception of the personal opportunities offered by such offices. But also the political parties have a duty to contribute to a solution for the recruitment problems.

## **Research Focus 4: Democracy and historical-political education**

*Politische Bildung goes to school!* In addition to the already mentioned game "Politik.Macht.Gesetz", further games on political education were developed in 2014, so that with the upcoming launch of [www.politischebildung.ch](http://www.politischebildung.ch) it will be possible to inform about several games and tools of varying playing times and content. Precisely because political education is so inadequately represented in schools, it is important to facilitate a targeted and selective implementation in lessons. The learning tool "Politikzyklus" will thus be offered for the first time. "Ja – nein – vielleicht" a game where one can practice arguing on topics relevant to democracy, augmented by images from the *Visual Reader Democracy*, as well as a role play where one competes for votes, to take part in the Federal Council, and for the governing topics from the perspective of political parties, will continue to be offered. The new developments will be made public in 2015 and be made available to the schools for implementation.

*Arbeitswelten* (PBGD). "Aushändeln" (deal-making), a game, will be developed as an iPad app for vocational schools and upper schools (secondary level I and II). The reader deals with the term and concept of democracy and visualises the texts with relevant picture series. The game brings images into focus that illustrate or represent an important issue for the concept of democracy. The choice of issues is based on the model of the democracy barometer, which facilitates the system and the references these in relation to each other. The game is being developed for the secondary school level I, and, with the implementation of a tablet, encourages group discussion by students who take on different roles. The quota of third-party funds shows the share of the cost financed by third-party funds. New is a differentiation between the shares of research funds gained competitively and commissioned research. The **third-party funds** acquired in the reporting year (averaging

35%) can, in terms of the social sciences and legal academic sectors, be considered to be very high. Remarkable is also the **share of competitively secured third-party funds** with a quota of **23%** of the total expenditure.

- The **administrative overhead expenses** (cost centre "**pool**") were lower than budgeted (approx. CHF 400,000) due to reduced business at the ZDA during construction work for the extension from May to November 2014. For the financing of the modernisation of the obsolete universal communications cabling (*UKV*) in the old building, funds set aside in 2013 were used.

From 2015, the rent will increase by approx. CHF 45,000 per year, mainly due to the completion of the additional office space created by the extension. Investments in furnishings and replacement investments for antiquated installations/equipment (locking system, office machines and additional capacities) as well as the correspondingly higher operating costs (cleaning, electricity) are likewise further costs. For this there are still reserves amounting to CHF 115,000. In addition, the post of public relations advisor ZDA will be institutionalised and charged to the 'pool'. The administrative cost contribution of the departments/partners will thus likely slightly exceed the cost ceiling of CHF 150,000. The relevant budget was approved by the ZDA GM on 3 November 2014.

- **C2d** was able to realise its ambitious budget of 40% third-party funding. Non-approved competitive project applications were compensated through the acquisition of several research projects from public and private institutions. The research projects on *e-democracy* (service level agreement with Canton Aargau and other cantonal and national partners, duration: 2012–2016) as well as research on the development of democracy in Latin America (Avina Foundation; 4-year extension 2014-17) remain important key areas. In addition, numerous new project applications were submitted; a 3-year SNF project by Andreas Glaser has already been approved (see section II).

Due to the high level of third-party funding and the efficiency of the long-standing research staff, personnel costs were lower than budgeted; it was possible to build up financial reserves, which will be helpful in the upcoming restructuring of human resources according to the new personnel regulations/strategy.

- **ADF** has also financed numerous projects and placements for qualifying positions (doctoral candidates, assistants) this year, in part using reserves from the start-up period 2008–2010. The third-party funding share was 30% in the reporting year (including the third-party funded professorship Kübler IPZ), and while lower than in the previous year, is still remarkable.

The department still has financial reserves at its disposal. However a large portion is earmarked to finance the PhD position "Demokratieforschung" (stipend 2014–2017) and institutionalise the democracy barometer at the ZDA. There are also reserves for the infrastructure of additional workplaces in the building's extension.

- **PBGD** has attained a third-party funding quota of 40%. Although this is lower than budgeted, it is significantly higher than in previous years. The quota was attained mainly with a number of development projects which could be realised this year.

Additional third-party funds would have resulted in an increase of employment. The lack of these funds was therefore directly compensated for by abandoning plans to add personnel.

**Remark:**

Budgeting of the expected third-party funds from public institutions (in particular SNF, federal authorities and the cantonal administration) as well as private organisations (foundations, NGOs, private companies and associations) is based on planned or pending project applications and/or expected commissions. The actual effected project approvals/commissions are very much dependent on external factors (eg. economic situation, political developments) and are difficult to assess.
